Conditions :

1. Taxis ordered by Municipal Commissioner for hiring & likely to hired should in very good condition. Preferably the models should be 2004 and 2005 onwards. They should be yellow board registration i.e., should be registered as taxis.
2. The vehicles has to move around City limits in Doddaballapur and by way.
3. Each of the cabs offered by the owner shall have a Driver exclusively, who is under employment of the owner. The payment of salaries, allowance and statutory payment to the services of the drivers engaged shall be responsibility of the owner. The drivers appointed by the statues. CMC shall not be responsible for any liability fastened on the owner on account of accident or the mishaps.
4. In case, the owner defaults in the discharging of any of the statutory liability the CMC reserves the right to deduct such amounts form the amounts payable to the owner.
5. The drivers shall wear such uniform as prescribed by the owner from time to time. He shall scrupulously follow instructions issued by the CMC. If and when the CMC finds deficiency with the driver (i.e., in his behavior, conduct etc.,) upon notice, the owner shall replace him with a substitute driver immediately. In such an event or any other event whir in the owner is liable to replace such a driver within a period of 7(seven) days notice, the cab provided with the driver on hire, shall be liable to the discontinued without prior notice.
6. The owners shall keep his cars road worthy As per the provisions set out in the Motor Vehicle Act 1988 and rules made there under from to time to time by carrying out necessary maintenance and repairs at owner's cost. At all times the cars must possess fitness certificates issued by the appropriate authority.
7. The owner shall supply fuel, lubricant oil, tyres and tubes, spare parts etc., all the inputs required for running the cars including maintenance, repair and upkeep of the cars at the owner's own cost.
8. It shall be the responsibility of the owner to produce at their own cost the drivers, cars both before the courts of law and before the Police Authorities, Whenever required in case of accidents or any orders, contingencies or any orders or discretions of the judicial or Executive Authorities.
